The background of this research is about ethics education and political culture discussing moral issues and political cultural background in DKI Jakarta Province. The National United and Politics Board has programs as referred to in Article 27 clause (1) of the Governor of OKI Jakarta Regulation, namely: Politics and Democracy Division has the task of carrying out the guidance and development of political culture education, democracy, and facilitation of political institutions. This research uses a qualitative approach. The focus of this research is on the Policy Strategy of the National United and Politics Board consisting of: Strategies, constraints or impediments, and solutions. From the research results, it was known that the implementation of ethics education and political culture aimed to provide understanding to the public on political ethics and culture as the embodiment of national and state life, carried out through seminars, community organizations, students, and workshops. Therefore, in general, ethics or morals is a philosophy, science or discipline concerning the modes of human behavior or the constancy of human action.

Ethics based on ratios to determine the moral quality of virtue is also called a philosophical system that questions human praxis regarding their responsibilities and obligations².

According to Miriam Budiarjo ³, political culture at this time has become an important thing in the implementation of public services. Aspects of the form and strategy of the program include the steps taken by carrying out various forms of socialization activities in general. While the aspects of obstacles or obstacles include participants who take part in the implementation of the ethics and political culture education program only ordinary people. For more details, it will be explained as follows:

1. Form and Strategy

Based on the results of the document study that the author did, it was explained that "The implementation of ethics and political culture education is carried out through socialization. Specifically, the socialization of increasing understanding of the 2018 Political Sector Law involved around 18,000 DKI residents. They consist of members and administrators of political

One of the main objectives and emphasis of these activities is to provide an understanding to the public regarding the ethics of political culture advice as the embodiment of the life of the nation and state." A more detailed explanation was given by Mr. Entis Sutisna as Secretary of the National and Political Unity Agency as follows:

"In the implementation of ethics education and political culture, participants are encouraged to understand the social and political order through, for example, deliberation about freedom, equality, and hegemonic social relations. By conducting socialization to various elements of society, involving several experts/experts from various institutions/academics as well as figures who have competence in their respective fields and implementing partnerships with political parties in DKI Jakarta Province in educating the public regarding the implementation ethics education and political culture"

2. Obstacles

Based on the results of the document study that the author did, it was explained that "In the implementation of ethics education and political culture there are two obstacles, namely internal and external constraints. The explanation was obtained that "the internal obstacle is that participants who take part in the implementation of the ethics and political culture education program are only ordinary people, even though what is expected by the National Unity and Political Agency is party leaders or party cadres. The external obstacle is that there is still a lack of understanding about the importance of ethical education programs and political culture from the community." A more detailed explanation was given by Mr. Entis Sutisna as Secretary of the National and Political Unity Agency as follows:

"Participants who take part in the implementation of the ethics and political culture education program are only ordinary people, even though what is expected by the National Unity and Political Body are party leaders or party cadres. First. Because the level of understanding and education of the people who participate in the socialization of the implementation of ethics education and political culture is still lacking, so that what is targeted is still not optimal. Second. The diversity of cultures and customs that exist in DKI Jakarta, so it is very difficult to provide socialization due to provocative differences of opinion. Third. People in DKI Jakarta are influenced by circulating issues such as hoaxes and so on."

3. Solution

Based on the results of the document study that the author did regarding the solution, it was explained that "the implementation of ethical education and political culture in overcoming any

obstacles or obstacles in its implementation, the National Unity and Politics Agency provides motivational encouragement to components or elements of society to create political dynamics that reflect culture and dynamic and democratic political ethics. The transformation of ethical values and political culture as well as their implementation must be continuously instilled and socialized to all components of society, so that it can color a democratic life that is more polite, cultured and more developed and meets the standards of norms and ethics of democratic political life." A more detailed explanation was given by Mr. Entis Sutisna as Secretary of the National and Political Unity Agency as follows:

"A solution that is carried out against obstacles or obstacles that arise related to the implementation of activities. the National Unity and Political Agency of DKI Jakarta Province, provides socialization to all components of society in DKI Jakarta Province on an ongoing basis and conducts friendly relations between the government and the community.
